### **PGY2 Oncology Pharmacy Residency**







#### **Program Overview**

The Oncology Specialty Residency Program (PGY2) offers three positions as a twelve-month program. The primary sites include the M Health Fairview University of Minnesota Medical Center (UMMC) and the M Health Fairview Clinic and Surgery Center (CSC). Additional clinic and pharmacy locations within M Health Fairview will serve as additional rotation sites. The program prepares the resident to become an oncology pharmacist through an array of advanced oncology focused core and elective rotations.

#### **PGY2 Program Purpose**

PGY2 residency programs build upon Doctor of Pharmacy (PharmD) education and PGY1 pharmacy residency training to develop pharmacist practitioners with knowledge, skills, and abilities as defined in the educational competency areas, goals, and objectives for advanced practice areas. Residents who successfully complete PGY2 residency programs are prepared for advanced patient care or other specialized positions, and board certification in the advanced practice area, if available.
