**Siyaasadda Oraah:**

M Health Fairview waxay leedahay taariikh fog oo ku aadan siinta daryeel caafimaad oo tayo leh macaamiisha bulshadeena iyo inay siiso daryeelka degdega ah bukaannada ayadoon ka eegayn awoodooda bixinta qarashka. M Health Fairview waxay aqoonsan tahay in bukaannada qaar ay awoodi waayaan inay iska bixiyaan dhammaan ama qayb ka mid ah kharashka degdegga ah ama adeegyada daryeelka caafimaad ee lagama maarmaanka ah ee la helay sababtoo ah ma haysan caymis caafimaad ama sababtoo ah kharashkooda daryeelka caafimaad ayaa ka badan awoodooda inay wax bixiyaan. Si loo siiyo kaalmada maaliyadeed u habboon kuwa u baahan, M Health Fairview waxay leedahay nidaam lagu qiimeeyo u-qalmitaanka bukaanka barnaamijyada kaalmada maaliyadeed.
